By signing below, I am agreeing to participate in the District of Columbia Municipal Aggregation Program ("DC MAP") and to be bound by its terms and conditions. Specifically, I agree that:

- 1. I have received the Municipal Aggregation Program Fact sheet and understand that I may request a copy of the service agreement with the Consultant, who will conduct the reverse auction and related services, for the DC MAP.
- 2. I agree that the District Department of the Environment Energy Office or its consultant is authorized to obtain my electric consumption data from Pepco and to contact Electricity Suppliers on my behalf. I agree that my consumption data will be used to solicit suppliers for DC MAP and will be submitted to Electricity Suppliers for bid.
- 3. I understand that the accepted bid will contain an adder that will be used to pay the costs of the DC MAP and the costs of the DC MAP Consultant.
- 4. I agree that returning the Opt-in Card binds me to a one-year contract with the winning Electricity Supplier. I understand that if there is no winning Electricity Supplier, my service will not change.
- 5. I understand that the winning Electric Supplier will notify Pepco of my change of supply service. If my meter read date is less than 17 days from the notification date my contract will not begin until the following meter read date. Pepco will confirm my choice of Electricity Supplier, resulting from my DC MAP participation, by sending a letter to me regarding my choice. I will have ten (10) days from the date Pepco sends a notice of enrollment stating my choice, to rescind my choice of Electricity Supplier.
- 6. I understand that a supplier will not be selected unless an acceptable bid offer of a rate less than the current Price-to-Compare^{*} rate is received including the adder in #3. The selected supplier will be licensed and meet all District requirements as determined by the DC Public Service Commission and the District's Utility Consumer Bill of Rights.
