3 CHAIR MILLER: Okay. We have two  
4 cases involving Paul Bakery. First case is 15-  
5 AUD-00021 and the second case is 14-AUD-00083.  
6 Paul Bakery is located at 801 Pennsylvania  
7 Avenue, NW, License Number 86639 in ANC 2C.

8 MR. RIVERO: Good morning, Board  
9 Members, Fernando Rivero for the District of  
10 Columbia standing in for Louise Phillips.

11 CHAIR MILLER: Good morning. And,  
12 sir, you are?

13 MR. CAUSEY: Good morning. My name is  
14 Henry Causey, the General Manager at Paul's  
15 Bakery.

16 CHAIR MILLER: Okay. Let me ask you,  
17 did you receive notice of this hearing?

18 MR. CAUSEY: Yes, ma'am.

19 CHAIR MILLER: Read it and understood  
20 it?

21 MR. CAUSEY: 100 percent, yes, ma'am.

22 CHAIR MILLER: Okay. So there's no

1 notice issues here with respect to this hearing.

2 All right. Are there preliminary matters, Mr.

3 Rivero?

4 MR. RIVERO: Yes. First, the licensee  
5 representative has a letter of representation  
6 that the Board should have.

7 CHAIR MILLER: Yes, thank you. Okay.

8 MR. RIVERO: Because the parties have  
9 an offer-in-compromise to present to the Board at  
10 this time for both cases.

11 CHAIR MILLER: Okay.

12 MR. RIVERO: For case ending in 00021,  
13 the fine is \$650, 30 days, and if not paid, the  
14 license will be suspended until payment received.  
15 For case ending in 00083, the offer-in-compromise  
16 is the same, another fine of \$650, within 30  
17 days, paid, or the license will be suspended  
18 until payment received.

19 CHAIR MILLER: Okay. All right. I  
20 was just taking a quick look at the letter that  
21 was passed up authorization you to appear and  
22 negotiate on behalf of the company for these two

1 cases.

2 MR. CAUSEY: Yes, ma'am.

3 CHAIR MILLER: Okay. So you're Mr.  
4 Causey?

5 MR. CAUSEY: Yes, ma'am.

6 CHAIR MILLER: Okay. Got it. Okay.  
7 Mr. Causey, do you agree to the offer-in-  
8 compromise presented for each of these cases of  
9 \$650 penalty to be paid within 30 days, and if  
10 not paid within 30 days, license will be  
11 suspended?

12 MR. CAUSEY: Yes, ma'am. Fully  
13 understand.

14 CHAIR MILLER: All right. And you  
15 understand that you waive your right to a  
16 hearing?

17 MR. CAUSEY: Absolutely, yes, ma'am.

18 CHAIR MILLER: Okay. And to an  
19 appeal.

20 MR. CAUSEY: Yes, ma'am.

21 CHAIR MILLER: Okay. Do Board Members  
22 have any questions?

1           MEMBER ALBERTI: Did you ask them if  
2 the report was filed?

3           CHAIR MILLER: I don't know. I may  
4 not have. Good question. What's the status of  
5 your quarterly statements? Have they been filed?

6           MR. CAUSEY: Yes, they have.

7           CHAIR MILLER: They have.

8           MR. CAUSEY: Absolutely. Yes.

9           MEMBER ALBERTI: Thank you.

10           CHAIR MILLER: All right. Okay. Then  
11 I'm going to move that we approve the offer-in-  
12 compromise for each of these cases of \$650 in  
13 each case to be paid within 30 days. If not paid  
14 within 30 days, the license will be suspended  
15 until paid.

16           MEMBER RODRIGUEZ: Second.

17           CHAIR MILLER: Okay. All those in  
18 favor -- Mr. Rodriguez has second the motion.  
19 All those in favor, say aye.

20                   (Chorus of ayes)

21           CHAIR MILLER: All those opposed? All  
22 those abstaining? Motion passes, 6-0-0.
