GRANT PROGRAMS

Clean Water Construction (CWC) Program

Funds the design and construction of voluntary stormwater green infrastructure and habitat restorations that help to improve District water quality. \$3,000,000 / year available in total.

Community Stormwater Solutions Grants

Funds community-oriented projects that improve water quality, raise awareness, and achieve behavior change about what citizens can do to restore our rivers, streams, and parks. Up to \$20,000 per project / year with \$200,000 available in total.

Green Zone Environmental Program (GZEP) Watershed Protection Projects

Funds hands-on activities and curriculum that restore District water bodies and raise awareness about the impacts of stormwater runoff on the District's watersheds. The projects are carried out with DOEE's Green Zone Environmental Program (GZEP), which provides paid training and work experiences to approximately 350 teenagers and young adults ages 14-24 through the Marion S. Barry Summer Youth Employment Program (SYEP). Projects Up to \$15,000 per project / summer with \$60,000 available in total.

Innovative LID Grant

Funds low impact development or green infrastructure projects that retain and treat stormwater. \$500,000 available in total.

RiverSmart Communities Demonstration Program

Funds 100% of the cost to install green infrastructure on eligible properties. Projects are selected through a competitive review process focused on environmental benefits of the project, plan for community engagement, and project cost effectiveness and feasibility. Eligible applicants include 501(c)(3) nonprofit organizations and houses of worship. \$20,000-\$30,000 /project, 3-5 projects funded per year. RiverSmart Schools Program

Funds design, installation, professional development, and curriculum development of schoolyard greening projects. \$3,500-\$170,000 / year.

REBATE PROGRAMS

Permeable Surface Rebate Program

Rebate program for private property owners who voluntarily remove impervious and compacted surfaces and replace them with permeable pavement and/or vegetation. \$5-\$10 / sq. ft. rebate. Learn More: https://doee.dc.gov/service/permeablesurfacerebate

RiverSmart Homes Rain Barrel Rebate Program

Funds rebate for property owners who purchase and install rain barrels or cisterns. Up to \$1,000 / property. Learn More: https://doee.dc.gov/service/rain-barrel-rebates

Stormwater Retention Credit (SRC) Aggregator Startup Grant

Funds SRC aggregators to design green infrastructure practices, typically across multiple sites, through technical and outreach work. \$75,000 / organization.
