



District Energy Benchmarking of Existing Buildings Covered Buildings List – 2019

This list contains all the Privately-Owned Properties in the District of Columbia over 50,000 gross square feet that are covered by the District of Columbia’s Energy Benchmarking Laws and Regulations in 2018 (D.C. Code § 6-1451.03; 20 DCMR 3513). It excludes buildings that were built in 2018. Please use this list to determine if your buildings need to submit benchmarking data to the Department of Energy & Environment (DOEE) by April 1, 2019.

The following fields are listed for all properties: the District of Columbia Real Property Unique Identifier, the Gross Building Area, the Premise Address, the Owner of Record or Condominium Name, and the Ward. This dataset is derived from the Computer Assisted Mass Appraisal (CAMA) database, the District's centralized real property database, maintained by the District’s Office of Tax and Revenue (OTR) and Office of the Chief Technology Officer (OCTO).

District of Columbia Real Property Unique Identifier:

The number is the District Government ID for real property as determined by OTR. For most properties, this is the property's *Square Suffix Lot (SSL)* or *Parcel* number. For condominium buildings, this is the Complex or *Square Suffix Regime* number (the regime number is a four digit number assigned to every condominium upon incorporation).

The number(s) should be entered in ENERGY STAR® Portfolio Manager® as the “**DC Real Property Unique ID**” in the “Standard IDs” list. If your property covers multiple parcels or tax lots (and is not a condominium), enter all included SSL/parcel numbers in the DC Real Property Identifier field in Portfolio Manager, separated by semicolons. If you have previously reported to DOEE, you should find this new field pre-populated with the correct number(s).

Gross Building Area:

This is the total gross floor area recorded for your tax or parcel lot, or the sum of all the condominium units, measured in gross square feet. ***Note that this number may not be the same as the building floor area as defined by EPA or the District’s benchmarking regulations.***

For example, the tax lot GBA numbers only count space above ground level. For condominiums, OTR does not track the size of common areas, so common areas are similarly not included. However, these spaces contribute to the energy use of the building, and so need to be included when benchmarking. For the purpose of benchmarking, EPA and DOEE defined gross floor area as the total floor area, expressed in square feet, measured from the principal exterior surfaces of the building(s) and not including parking area(s). It includes spaces not included in net floor area, such as mechanical rooms, elevator shafts, basements, and interior walls.

Many tax lots have more than one building on the lot. Unfortunately, OTR does not track the size of individual buildings in such cases. Pursuant to DOEE's regulations, if your property has energy or water meters, or building systems (such as a central gas furnace), shared across multiple buildings without sub-metering, then the energy use cannot be attributed to any individual building. In such cases, the building must be benchmarked as a single property in Portfolio Manager, and the floor area threshold for compliance with the benchmarking requirements is the total floor area of all buildings sharing systems.

If you think the OTR listed floor area is in error *by a sufficient amount to affect when or if you have to comply* with the benchmarking regulations, please contact DOEE at info.benchmark@dc.gov and explain your situation. Signed, supporting documentation will be required. A re-appraisal of your property by OTR may be requested.

Disclaimer:

Inclusion on, or absence from, this list does not represent ultimate legal determination of whether a building is covered by the regulation. If you believe your building is over 50,000 gross square feet, you are still required to report by April 1, 2019 even if you do not see your building on this list.
