A1. A grantee may secure experts, consultants, and/or other needs through appropriate procurement pathways including competitive contracts as needed to fulfill the requirements of the subgrant.

Q2. Please confirm that the Grantee may be able to request and receive exemptions to certain insurance requirements depending on the extent of coverage needed by the District for this Project.

A2. A grantee may request exemptions to insurance requirements. More information will be needed to determine if such exemptions will be granted.

Metropolitan Statistical Area (MSA) as including the following counties:

District of Columbia, DC; Calvert County, MD; Charles County, MD; Frederick County, MD; Montgomery County, MD; Prince George's County, MD; Arlington County, VA; Clarke County, VA; Culpeper County, VA; Fairfax County, VA; Fauquier County, VA; Loudoun County, VA; Madison County, VA; Prince William County, VA; Rappahannock County, VA; Spotsylvania County, VA; Stafford County, VA; Warren County, VA; Alexandria city, VA; Fairfax city, VA; Falls Church city, VA; Fredericksburg city, VA; Manassas city, VA; Manassas Park city, VA; Jefferson County, WV.
