Rulemaking Process (Nicole/Katie)

- Reviewed general outline of rulemaking process; pre-clearance, OGC legal sufficiency, stakeholder engagement with draft language, final draft approved by OPLA for publish, comment period, publish final version
- Reviewed overall 2020 timeline to have BEPS rules finalized by January 1, 2021 (see slides)
- TF would like to publish standards as soon as possible after the rules are finalized in Fall 2020

Proposed Topic Schedule (Kate)

- Dec 10 setting the stage
- Jan 7 property types, equivalent metric
- Jan 21 prescriptive path, other pathways
- Feb 4 exemption criteria and process, fines and enforcement
- Feb 18 campus standard, other

- After rule-specific topics are discussed, TF will work on other items such as incentives and education and move to a less frequent meeting schedule
- Other items? Affordable housing specifics? Third party data verification discussion for Jan 7 meeting? Documentation, submittal and review during compliance? What is DC's process on enforcement before the fines meeting? More on performance pathway and current legislative language? Financial assistance and resources?

- Comments from TF
 - Enforcement other monetary penalties than fines, non-monetary penalties, fines cannot be passed on to tenants, other alternative compliance payments, taxes; key takeaway that penalties should encourage compliance rather than generate revenue
 - CEDC Act consider interaction with other elements of the CEDC Act, e.g. 100% renewable energy procurement
 - Early Compliance think about possible early compliance options for buildings that are refinancing in 2021 or 2022
