- 1. Administrative (slides 1-5)
 - a. Opened Meeting at 2:32pm
 - b. Attendance taken by roll call (see above); Quorum not achieved at the time of roll call, but no decisions being made during this more informative/discussion meeting; so TF members present agreed to proceed; Quorum achieved later in meeting.
- Sharon reviewed partner slide set stage for feedback session (slide 6)
- 3. DCSEU Feedback session (slide 7-14)
 - a. Overview
 - i. ~\$30 million annual budget, ~25% must be for low-income
 - ii. BEPS Support efforts so far include benchmarking guidance, other energy efficiency trainings, Task Force participation, support Building Innovation Hub
 - iii. Continuing support via these and things like Pay for Performance, building relationships with Green Bank/partners, developing and providing more outreach and education
 - b. Pay for Performance program is one year old
 - Baseline buildings and then monitor performance over time (usually one year), with incentives paid on incremental improvement over time. Most useful for largest commercial customers because requires benchmarking
 - ii. I think it'd be really helpful to get more specific information on the P4P program, such as what targets buildings were shooting for on the whole, what EE measures they were implementing/aiming to implement, etc.

- (aggregate is fine). Crystal will request performance data for first year of program so far that can be shared with the TF
- c. DCSEU's current offerings tend to help short payback EE projects the most, like lighting upgrades. What could DCSEU do to help longer term payback EE projects better in future years, like envelope upgrades, when these projects tend to be the ones that need the assistance the most? The incentives work better for shorter projects because of the way the DCSEU contract and budget is structured.
- d. Can you describe the process for the custom program that Crystal mentioned?
 - i. Customers engage by contacting DCSEU; DCSEU will work directly with customer to scope out work, factoring in budget, goals, needs, etc.; If technical assistance needed, engineer will get involved, ask questions, maybe site visit to gather information for a building analysis, then discuss what potential incentive level will be based on scope; If additional financial support needed then, DCSEU will connect project with PACE or Green Bank; Case manager assigned to a project stays with that project to build and maintain relationship, indefinitely

- 4. Deep Energy Retrofit update (slide 15-21)
 - a. Accelerated DER update (slide 17)
 - i. Is 75% maintenance for each cycle or just the first waiver cycle?
 - 1. DOEE to confirm
 - ii. Is this a principal pathway?
 - 1. Principal Pathways are performance, standard target and prescriptive. All others are either a "pre-approved" Alternative Compliance Pathway or a custom ACP application.
 - b. Extended DER recommendations from campus sub-committee (slide 18-21)
 - These slides reflect recommendations from the BEPS campus subcommittee (that was officially closed with the last meeting on Nov. 10)
 - ii. Question Could this pathway be open to other sectors than just affordable multifamily housing or hospital/higher education campuses? DOEE is open to other sectors applying for a custom ACP to pursue this path, but would need to have good cause.
