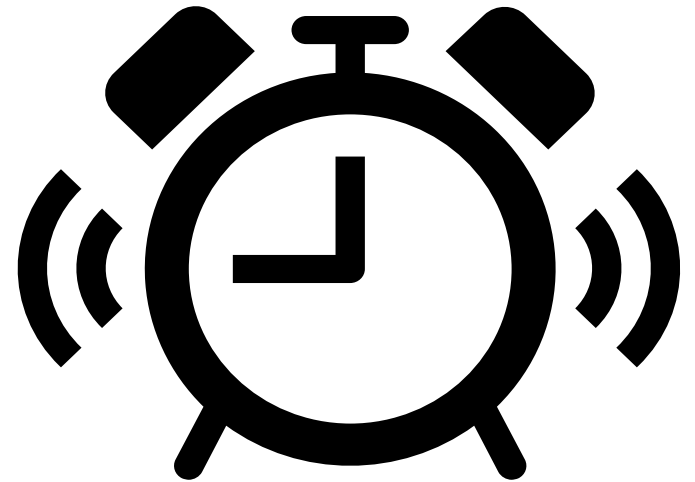

Project Details

- The purpose of this proposal is to solicit applications for a partner or partners that we will include in our application to EPA. The partner will 1) **collect and analyze hyper-local** air pollution data; 2) help DOEE **develop potential municipal intervention and adaptation strategies**; and 3) **communicate** this information to families and decision makers.
- The amount available for the project is **approximately \$1,000,000**.
- Project Period – DOEE will submit its application to EPA by **June 26, 2024**. If we receive an award from EPA, the project will go through December 31, 2027.

What the partner will do

- 1) Collect hyperlocal air quality data and data relevant to elementary students' health and learning accessibility. Data will be collected throughout the period of the grant.
- 2) Analyze data and determine sources of pollution near the targeted elementary schools.
- 3) Work with DOEE to develop potential municipal intervention strategies tailored to the profile of the emissions as well as adaptation strategies that students and caregivers can use.
- 4) Communicate the air quality information gathered and analyzed to local communities, including the families of the students attending the schools, and decision-makers.

What else we're looking for

Proposals should include any of the following elements and additional points will be awarded to applications that include all elements:

1. Quality assurance plan;
2. Community engagement plan;
3. Research elements relevant to this proposal, including demonstrated understanding of EPA regulations for working with human subjects;
4. Explanation of how any data monitoring will be sustained after the end of the project period.

Scoring Criteria

All eligible applications will be evaluated based on the criteria in the RFA.

Scoring Criteria	Points
Presents a highly qualified team to coordinate project partners	15
Presents a detailed data collection and analysis plan	15
Presents a plan to reach out to targeted elementary schools to set up monitors	15
Presents a creative plan to present information to District residents	15
Explains how to present complex information in simple and culturally appropriate ways	10
Experience with developing municipal intervention strategies	10
Demonstrates the understanding of human subjects' research protocols	10
Presents a detailed cost-effective numeric budget	5
Provides a budget narrative that supports the budget numbers.	5
