

We want you to help us increase public participation in DC-wide air quality decisions and empower residents to be better advocates on air quality issues!

Project Details

- The purpose of this grant is to 1) develop and oversee a 7- to 15-person advisory committee; 2) collect and disseminate residents' stories and experiences with poor air quality; and 3) inform the public about a newly created online mapping tool that will provide localized real-time air quality data.
- The amount available for the project is \$81,246.
- Project Period –the project will start on the date the grant is signed and will run through April 30, 2025. This period can be extended depending upon DOEE'S determination of the performance of the grantee and/or the availability of funds.

What the grantee will do

- 1) Organize an Air Quality Advisory Board (AQAB) whose membership should reflect Wards 1, 4, 5, 6, 7, and 8 and include air quality and health technical experts.
- 2) Identify and interview residents of affected neighborhoods on the effects of air quality on their lives. The interviews should be filmed and will be posted on DOEE's online mapping tool.
- 3) Work with the AQAB to develop and disseminate information about the new Air Quality Mapping tool. DOEE will create the tool after the grantee solicits community input on its design. Once the online tool has been completed, the grantee will work with AQAB, DOEE, and other partners to develop and implement an outreach campaign to educate District residents about it.

All eligible applications will be evaluated based on the criteria in the RFA.

Scoring Criteria	Points
Demonstrates existing relationships with diverse Environmental Justice communities on which the project will focus.	15
Presents a clear and comprehensive plan for creating and working with the AQAB.	15
Understands air quality and environmental burdens in the District.	15
Experience in videography and video editing or working with a partner/contractor who can do this.	15
Presents an engaging way to identify and encourage residents to share their stories related to air quality.	15
Experienced in managing groups and community outreach.	10
Provides a detailed budget that is cost-effective.	10
Provides a budget narrative that supports the budget numbers.	5
