✓ Commit to Environmental Restoration and Community Environmental Projects

Synergy & Serenity is actively engaged in fostering environmental restoration and community engagement initiatives, emphasizing composting as a key element in its commitment to sustainability.

Vermiculture Composting Classes: Regular classes are conducted to educate participants on vermiculture composting, imparting knowledge on small-scale systems suitable for apartments.

Composting Structure Workshops: Workshops are hosted to guide participants in building indoor or apartment-sized composting structures using recycled materials, promoting creative and sustainable solutions.

Partnerships with Restaurants and Local Gardens: Collaborations with local restaurants and gardens establish a composting pipeline, collecting kitchen waste to create nutrient-rich compost, reducing organic waste in landfills.

Collaboration with Composting Companies: Synergy & Serenity collaborates with composting companies to efficiently process compostable materials collected from various sources, closing the loop on organic waste recycling.

Plant Plots from Recycled Materials: Educational programs include teaching participants how to create plant plots using recycled materials, promoting sustainable gardening practices and resourcefulness.

✓ Composting

Fruits and Vegetables:

Non-acidic fruits (excluding citrus fruits)
Vegetables (excluding acidic varieties and onion peels)
Quantities vary based on kitchen waste generated from staff following a predominantly vegetarian diet.

Cardboard:

Cardboard from used boxes is collected for composting.

The amount depends on the facility's consumption and packaging materials.

Paper Waste:

Mail without plastic slips is included in composting efforts.

The quantity is based on the incoming mail and administrative activities.

Shredded Biodegradable Products:

Shredded biodegradable materials are composted. Quantities are determined by the volume of materials generated within the facility.

Leaves:

Leaves contribute to the carbon-rich component of the compost. The amount is seasonal and depends on the availability of leaves.

Composting Frequency:

Approximately five 5-gallon buckets of compost are compiled every six months.

✓ Employee Commute/Customer Travel

Metro Passes: The majority of our employees utilize metro passes as their primary mode of transportation, contributing to reduced single-occupancy vehicle trips.

Encouraging Public Transportation: By promoting the use of metro passes, we actively encourage employees to opt for lower-emission, sustainable transportation methods, reducing the environmental impact associated with single-occupancy vehicles.

Eco-Efficient Company Vehicle: The single employee who uses a personal vehicle for commuting and business purposes owns an eco-efficient car. This choice aligns with our commitment to minimizing the carbon footprint associated with transportation.

Limited Single Occupancy Vehicle Use: With only one employee relying on a personal vehicle, we successfully reduce the number of single-occupancy trips associated with our business operations.

Bike Parking: To further support sustainable transportation, Synergy & Serenity provides bike parking facilities, encouraging employees and customers to choose eco-friendly alternatives for shorter trips.
